

## **Sustainability Policy**

For CEME, "sustainability" means an inescapable element that is deeply rooted in the Group's everyday activities, a pivotal enabler for its corporate strategy. As a consequence, product quality and corporate social responsibility in all operations are key drivers for CEME's brand success and market dominance, together with process excellence and the sustainable management of the Group's suppliers. Reconfirming its full adherence to the principles and values that constitute the foundations of the UN Global Compact, this document is intended to unveil CEME's sustainability pillars.

The Group's undertaking towards sustainability is rooted in the Code of Ethics, which sets the unavoidable rules of behaviour that apply to all CEME's people and operations at all latitudes. Among these, the following principles are to be considered as those that underpin the Group's commitments to sustainability:

- People and equal opportunities: the Group acts by respecting the fundamental rights of
  every individual and by guaranteeing equal opportunities and the fight against any form of
  discrimination. CEME undertakes to safeguard every person's physical, moral and cultural
  integrity, while pledging to work conditions that do not threat individual dignity.
- **Safety and workplace**: the Group recognizes the health and safety of workers as a fundamental enabler. For this reason, CEME adopts every precaution that is necessary for its employees and collaborators to carry out their activities in conditions of healthiness, safety and hygiene.
- **Environment, quality and organizational structure**: the Group considers the environment as important as quality, the true primary focus of all its operations. Thus, CEME promotes a culture of respect for the environment, applying principles of advanced environmental protection and energy efficiency across all operations.
