Saipem SpA aims to be an exemplary leader in Health, Safety & Environment (HSE), just as it is in the management and execution of EPIC projects for the Oil & Gas industry, Core to Saipem's values are the health and safety of its people, clients, visitors and business partners and the management of its potential environmental impacts.

Saipem SpA seeks to create a culture in which Health, Safety and Environment principles are guiding strategies and part of everyday business, and is committed in minimising the risk of injuries, occupational illnesses, and impact to environment, to social context and public safety

Saipem recognises the importance of HSE aspects in all its activities, at all levels, during all phases of projects and services, in countries in which it operates. This is why HSE key performance indicators are set and monitored, and challenging objectives periodically identified and reviewed in order to achieve continuous improvements.

Without prejudice to its commitment to comply with applicable legislation, guidelines and standards required by international organisations (such as IMO, ISO and OHSAS), Saipem pursues specific objectives to reach its own "Health & Safety Vision" and to ensure proper management of environmental issues.

These objectives include, but are not limited to:

- raising awareness on Environmental, Health and Safety aspects,
- continuously promoting the culture for environmental protection and safeguarding of local context, public safety, workplace health and safety;
- ensuring thorough identification and assessment of all HSE risks and ensuring prompt and appropriate
  mitigation and control measures in all operations, including those executed by vendors, subcontractors
  and JV partners; in particular risks for:
  - o the health and safety of employees and of anyone who may be affected by its operations;
  - o the pollution and potential damage to the environment caused by its operations;
  - the integrity of its assets in order to prevent and control any failure that could lead to a major accident event;
- conducting HSE due diligences during mergers and acquisitions, aimed at identifying existing and
  potential HSE impacts associated with any previous building, infrastructure, historical activity and
  current practice, including potential liabilities associated with pre-existing pollution;
- introducing highly efficient and low energy demanding solutions, low environmental impacting products, and supporting climate protection initiatives and protecting environmental biodiversity, and ensuring the efficient use of energy and natural resources;
- including HSE criteria in the selection and evaluation of subcontractors and vendors.

Saipem aims to achieve these objectives by:

- ensuring the availability of appropriate human, technical and financial resources;
- assuring that only competent personnel is assigned to perform own tasks
- providing adequate knowledge and skills to all employees on HSE issues
- taking into account:
  - ✓ the commitment to eliminate hazards and reduce OH&S risks:
  - the commitment to consultation and participation of workers.
- reiterating the importance of the "lifesaving rules" and ensuring zero-tolerance towards any deviation;
- enhancing focus and awareness on environmental, health and safety issues through the programme "Leadership in Health and Safety" and implementation of specific environmental initiatives and campaigns;
- reiterating the responsibility and the right of anyone to call a halt to activities that could potentially compromise health and safety conditions, and actively supporting those who intervene to stop such actions and operations;
- defining roles, responsibilities and procedures to plan, execute, monitor and control suitable and sufficient actions to ensure barriers are preserved and assets are adequate to perform the processes and activities which they are designed for
- maintaining its certification of compliance with ISO 14001 and BS-OHSAS 18001 international standards;
